- THE STATE OF MINNESOTA HAS NOT ADOPTED ANY EDUCATIONAL AND TRAINING STANDARDS FOR UNLICENSED COMPLEMENTARY AND ALTERNATIVE HEALTH CARE PRACTITIONERS. THIS STATEMENT OF CREDENTIALS IS FOR INFORMATION PURPOSES ONLY

Under Minnesota law, an unlicensed complementary and alternative health care practitioner may not provide a medical diagnosis or recommend discontinuance of medically prescribed treatments. If a client desires a diagnosis from a licensed physician, chiropractor or acupuncture practitioner, massage practitioner, nurse, osteopath, physical therapist, dietitian, nutritionist, athletic trainer, or another type of health provider, the client may seek such services at any time.

- Clients of Schroeder Chiropractic have the right to file a complaint and may do so, in writing, at the address of the top of this form. Clients may also contact the Minnesota Department of Health to file a complaint at:

- Payment Policies:
 - Payment in full is due at the time of service.
 - Schroeder Chiropractic gladly accepts cash, check, and credit
 - Massages are provided in 30, 60, 90, and 120 minute sessions.
 - Rates: 30 minute = \$40, 60 minute = \$70, 90 minute = \$85, 120 minute = \$110
 - All clients of Schroeder Chiropractic have the right to 30 day written notice of changes in services or charges. These notices will be provided through the mail unless otherwise requested.
 - Schroeder Chiropractic acknowledges and supports the client's right to have full knowledge of and participate in his/her own treatment process. This includes practitioner's assessment, recommended service to be provided and expected duration of that service.
 - Schroeder Chiropractic strives to encourage and promote the wellness benefits of massage therapy by providing quality professional massage to people from many different backgrounds and income levels.
 - Clients can expect to be provided with helpful, courteous service that is free of verbal, physical and sexual abuse.

- All clients' records and transactions with Schroeder Chiropractic are confidential, unless release of these records is authorized in writing by the client or otherwise provided by the law.
- Clients have the right to choose freely among massage therapy practitioners and to switch practitioners or to refuse services or treatment at any time over the course of the treatment within the limits of the law, health insurance, medical assistance, or other health programs. Clients have the right to coordinated transfer when there will be a change in the provider of services.
- Clients are always invited to assert their rights without retaliation.
